A. Documentation requirements for Macau or Hong Kong resident Accounts:

- 1. Macau / Hong Kong Resident Permanent Identity Card
- 2. Residential Address Proof (e.g. utility bill or bank statement issued within 3 months)
- 3. * Personal Account Opening Form
- 4. * Personal Account Signature Card
- 5. * W8 / W9 Form
- 6. * Tax Residence Self-Certification Individual

B. Documentation requirements for Chinese resident Accounts:

- 1. Valid Passport or Identity Card and other travel document
- 2. Residential Address Proof (e.g. utility bill or bank statement issued within 3 months)
- 3. * Personal Account Opening Form
- 4. * Personal Account Signature Card
- 5. * W8 / W9 Form
- 6. * Tax Residence Self-Certification Individual
- 7. Acceptable letter of recommendation from our correspondent banks (if required)

C. Documentation requirements for Other Accounts:

- 1. Valid Passport and travel document
- 2. Residential Address Proof (e.g. utility bill or bank statement issued within 3 months)
- 3. * Personal Account Opening Form
- 4. * Personal Account Signature Card
- 5. * W8 / W9 Form
- 6. * Tax Residence Self-Certification Individual
- 7. Acceptable letter of recommendation from our correspondent banks (if required)

Notes:

- 1. Apart from the above documents, the Bank may further request you to provide more account opening details and documents when necessary.
- 2. The above documentation requirement enables us to comply with KYC and other regulatory requirements.
- 3. Copies of the documents submitted should be true copies certified by notary public or correspondent banks.
- 4. Signatures appearing on account opening form, signature cards, facsimile and email Instruction indemnity form and other relevant forms must be verified by notary public or correspondent banks for those who are not present for the account opening.
- 5. The Bank may, at its discretion, require a letter of recommendation concerning the holder of the account from a correspondent bank or another bank it considers reliable.
